IT IS FURTHER ORDERED that any and all applications for Reinstatement of Occupational Licenses, (also known as Certificates of Relief from Disabilities), Expungement of Records, Sealing of Records, Certificates of Innocence, and Certificates of Good Conduct, as well as petitions for review of the denial of the issuance of FOID

card applications by the Illinois State Police shall be assigned to and heard by the Presiding Judge of Felony of this court or his/her designee.

IT IS FURTHER ORDERED that the Clerk of the Circuit Court shall ensure that the case reassignment monitoring system is updated to reflect the above stated assignments for the dates stated and that the judge assignment packets are changed at the earliest possible time to reflect the proper judge name.

IT IS FURTHER ORDERED that all trial and motion dates for cases affected under this Order shall remain as scheduled unless otherwise ordered by court.
