### Location

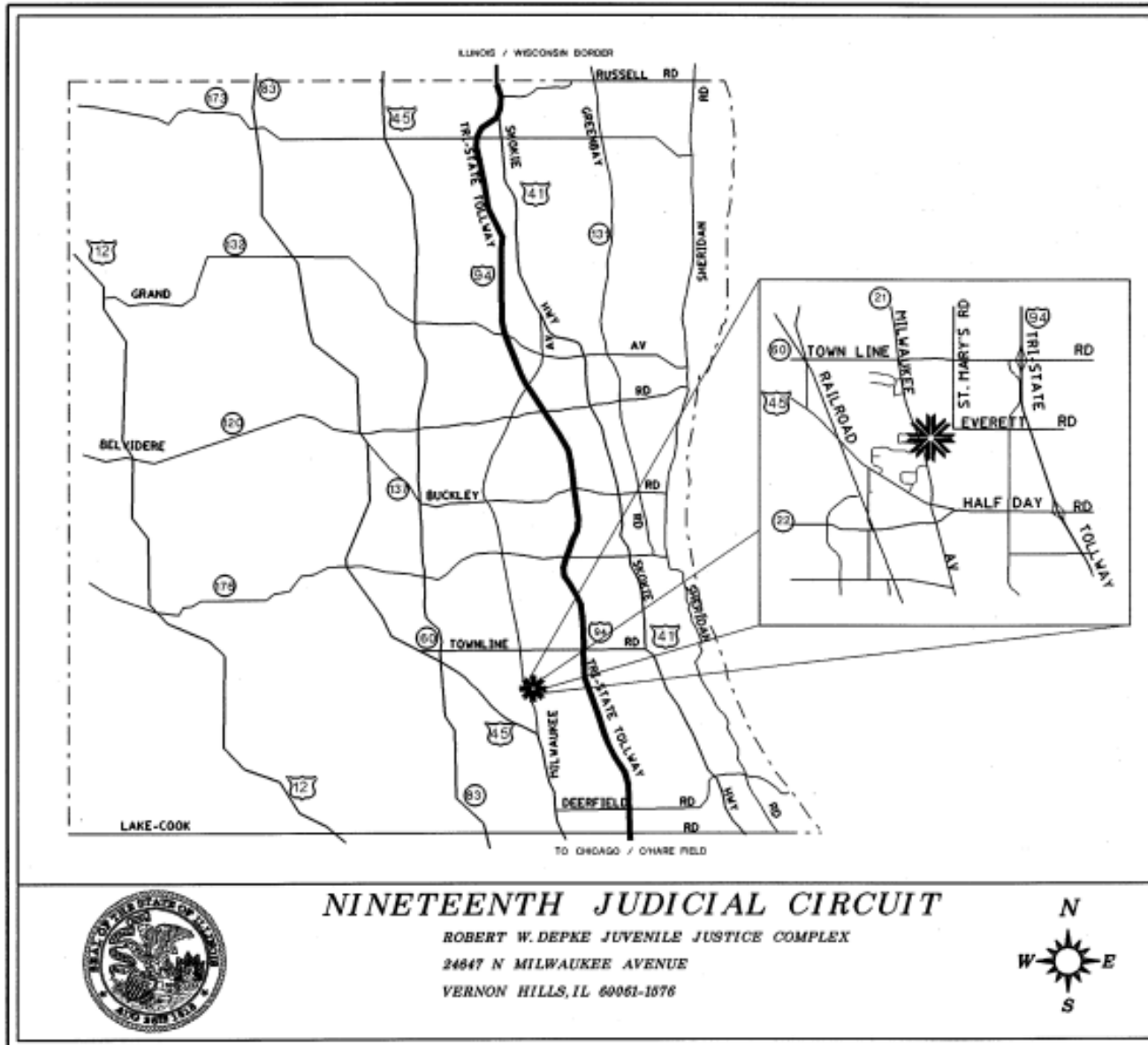
The Robert W. Depke Juvenile Justice Center and the Minard E. Hulse Detention Center are located adjacent to each other. The entire juvenile facility is approximately 1.5 miles south of the Vernon Hills Shopping Center (Route 60) on the east side of North Milwaukee Avenue (Route 21).

### Building Entrances

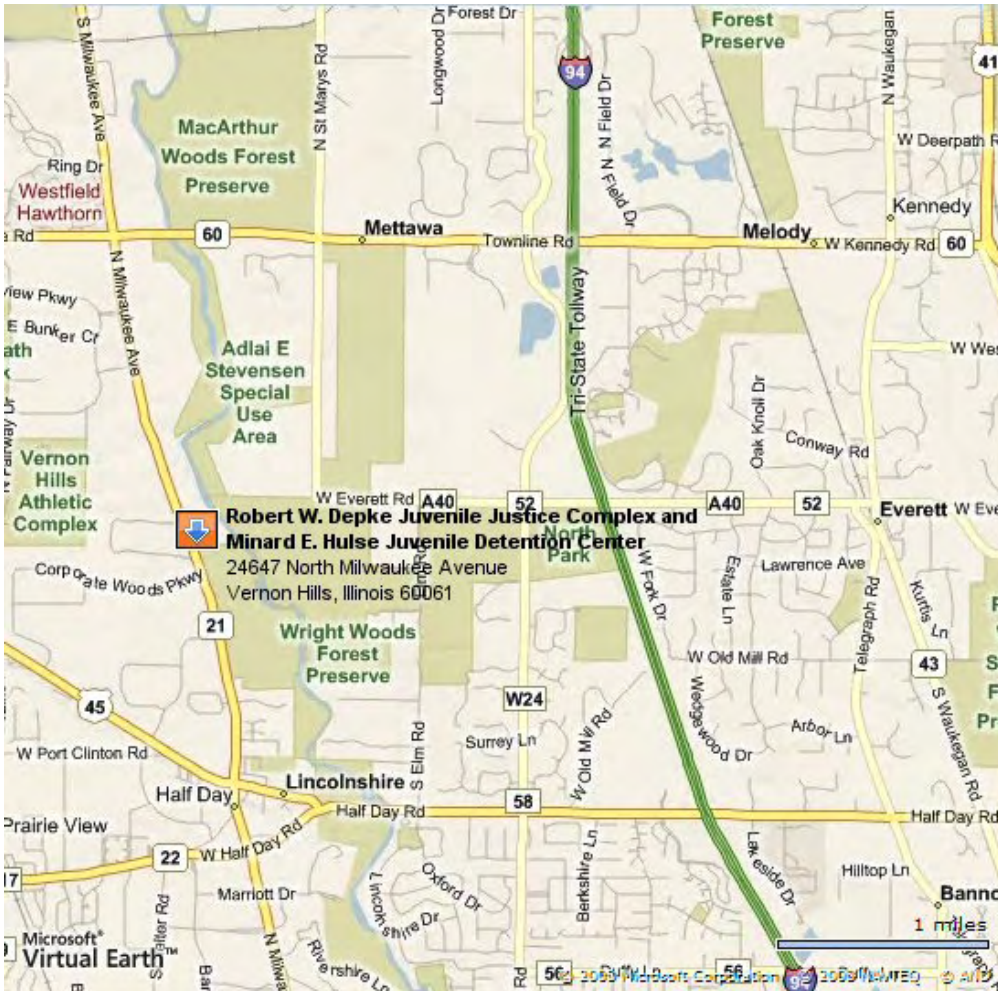
Entrances available from NW and NE corners of building.

## Directions

### If coming from the Tri-State Tollway (I-94) using Town Line Road (SR 60):

Exit onto Town Line Road (Route 60) west bound. Go west on Town Line Road (2.1 mi), turn left onto N. Milwaukee Avenue (SR-21) (1.5 mi) to the Juvenile Justice Complex on the left (east) side of the road.

### Alternately you can exit the Tri-State Tollway (I-94) using Half Day Road (SR 22):

Exit onto Half Day Road (SR 22) west bound. Continue west on Belvidere Road (2.0 mi), right onto Old half day Road (0.4 mi) to the traffic light at Milwaukee Avenue. Turn right onto N. Milwaukee Avenue (SR 21) (1.1 mi) to the Juvenile Justice Complex on the right (east) side of the road.

### If coming from Skokie Highway (US 41) using Town Line Road (SR 60):

Exit onto Town Line Road/W Kennedy Road (SR 60) west bound. Go west on Town Line Road (4.2 mi), turn left onto N. Milwaukee Avenue (SR-21) (1.5 mi) to the Juvenile Justice Complex on the left (east) side of the road.

### If coming from the main courthouse in Waukegan:

Turn right onto Washington Street (0.3 mi) to Glen Rock Ave. Left onto Glen Rock Avenue (0.9 mi) to Belvidere Street (SR 120). Right onto Belvidere Street to S O'Plaine Road. Left onto O'Plaine Road (2.6 mi), right onto W Buckley Road (SR 137) (0.4 mi) to N. St Marys Road. Left onto St Marys Road (4.6 mi) to Town Line Road. Right onto Town Line Road (1.0 mi) to N Milwaukee Avenue (SR 21). Left onto N. Milwaukee Avenue (SR-21) (1.5 mi) to the Juvenile Justice Complex on the left (east) side of the road.

**Total Distance:** 14.5 Miles, **Estimated Driving Time:** 30 minutes with traffic
