

Location

The South Branch Court (Mundelein) is located on the southwest corner of Wilson Ave. (State Routes 83/60) & Diamond Lake Road.

Parking


Parking is available onsite. Enter from either northbound Diamond Lake Road or from East and West bound Wilson Ave. (State Routes 60/83).

Note: You cannot enter from southbound Diamond Lake Road.

Building Entrances

The Public Entrance is available from the front of the building facing State Routes 83/60.





Directions

If coming from the east on Route 60: Get into center right turn lane onto Route 60/83, go north (right turn) approx. 1 tenth of a mile, turn left into the branch court parking lot.

If coming from the northwest on Routes 60/83: Make a right turn into the branch court parking lot just after the intersection of Diamond Lake Road and Route 60/83 just south of the new convenience store/gas station.

If coming from the south on Diamond Lake Road: Turn right into court parking lot just after the school and before the Route 60/83 stoplight.

(There is no southbound exit back onto Diamond Lake Road, northbound only)

Route if coming from main Courthouse in Waukegan: Go west on Washington St approx. 2.1 miles to Green Bay Road. Turn left (south) onto Green Bay Road, go approx. 0.7 miles. Turn right (west) onto Belvidere Road (SR-120), go approx. 2.6 miles to I-94. Turn right onto the I-94E ramp, merge onto I-94 (Tri-State Tollway), go south approx. 7.4 miles to the Town Line Road (SR-60) exit. Exit right onto ramp towards Townline Road (SR-60), turn right (west) onto Townline Road (SR-60) and go approx. 5.0 miles to Route 60/83. Get into the center right turn lane onto Route 60/83, go north (right turn) approx. 1 tenth of a mile, turn left into the branch court parking lot.

Total Distance: 18.6 Miles, Estimated Driving Time: 23 minutes

Route if coming from Lakehurst Branch Court A or B in Waukegan: Go north onto Greenleaf Road approx. 0.2 miles, take ramp left (west) onto Belvidere Road (SR 120), go approx. 1.2 miles to I-94 Tollway. Turn right onto the I-94E ramp, merge onto I-94 (Tri-State Tollway), go south approx. 7.4 miles to the Town Line Road (SR-60) exit. Exit right

onto ramp towards Townline Road (SR-60), turn right (west) onto Townline Road (SR-60) and go approx. 5.0 miles to Route 60/83. Get into the center right turn lane onto Route 60/83, go north (right turn) approx. 1 tenth of a mile, turn left into the branch court parking lot. **Total Distance**: 14.5 Miles, **Estimated Driving Time**: 17 minutes

Route if coming from North Branch Court in Round Lake Beach: Go right (south) approx. 1 tenth of a mile. At the stoplight, turn right onto Rollins Road. Go east on Rollins Road approx. 1 mile. Turn right (south) onto Ivanhoe Road (SR 83). Go approx 7.9 miles south to SR 83/60. Bear left onto SR 83/60, go approx 3.5 miles to just south of the stoplight at Diamond Lake Road. Turn right into the branch court parking lot. **Total Distance**: 12.5 Miles, **Estimated Driving Time**: 18 minutes
