SIXTEEN APPLY FOR ASSOCIATE JUDGE POSITION

Chief Judge Victoria A. Rossetti received official word from the Administrative Office of the Illinois Courts that sixteen attorneys have timely filed their applications for the associate judge vacancy created by The Honorable Daniel B. Shanes' appointment to fill the vacancy created by the retirement of The Honorable Raymond J. McKoski, Circuit Judge.

The applicants will be interviewed by the Circuit Judges and they will be evaluated by the Lake County Bar Association. Public comment by letter is invited on or before December 13, 2010 addressed to: Chief Judge Victoria A. Rossetti, Lake County Courthouse, 18 N. County Street, Waukegan, IL 60085-4359. Once the review process is completed, the nominating committee consisting of Circuit Judges will select the names of two candidates to be placed on a ballot. Said ballots will be returned to and tallied by the Administrative Office of the Illinois Courts in Springfield.
