Lake County Chief Judge Jay Ukena said that Lake County judges have a long history of being very active in community organizations. "The judges of the 19th Judicial Circuit believe that it is vitally important that the judges be involved in their community, and that includes the legal community," Judge Ukena said. "Our judges strive, both on and off the bench, to make the legal system and the judiciary the best that it can be. The ISBA and LCBA provide professional services and education to Illinois lawyers and to the public. The IJA supports judicial excellence and professional development, including judicial educations. The IJF is a philanthropic organization comprised of current and retired judges, funding education, civic, and scholarship projects.

Committees and councils have the responsibility for specific programs and activities in a variety of areas, including professional ethics, continuing legal education and legislative services.

"It is an honor to serve on these councils and committees," said Lake County Associate Judge Elizabeth Rochford, who has been appointed to various positions within these organizations. "As judges, we work for the people and endeavor to make the justice system here in Illinois the best in the nation. These organizations work toward that same end."
