LAW DAY U.S.A. was adopted officially as a project of the American Bar Association in 1957. President Dwight D. Eisenhower established Law Day by Presidential Proclamation in 1958.

In 1961 the date of May 1 was set aside by joint resolution of Congress to be observed annually as a "special day of celebration by the American people in appreciation of their liberties and the reaffirmation of their loyalty to the United States of America," and as an occasion for "rededication to the ideals of equality and justice under laws."

The purpose of Law Day is to call the attention of American citizens of all ages to both the principles and practice of American law and justice. It is a day to reflect on our legal heritage, and the role of law in our society and the rights we enjoy under our Constitution.

Law Day is also a day for citizens to consider their duties, such as to be informed on government and community affairs, to support and encourage efforts to modernize our courts, to vote in elections, to obey and respect the law, to support those institution and persons charged with law enforcement, to respect the rights of others, to practice and teach the principles of good citizenship in our homes, and to serve on juries and as court witnesses, if called.
