SUPPLEMENTAL SENTENCING ORDER
IMPACT INCARCERATION

This matter coming on to the Court for sentencing, the defendant having been found guilty and sentenced as set out in the Judgment and Sentence Order attached hereto; and the Court having considered the provisions of Chapter 38, par. 1005-8-1.1 (Impact Incarceration) does find:

1. That the defendant herein meets the eligibility requirements of par. 1005-8-1.1(b) (1)-(6).
2. That the defendant has consented in writing to participation in the impact incarceration program and to the terms and conditions thereof.
3. That this Court recommends and approves this defendant for placement in said program.

IT IS THEREFORE ORDERED:

- A. That the defendant is sentenced to _____ years/months in the Illinois Department of Corrections as set out in the attached judgment.
- B. That if the Department of Corrections accepts the defendant in the impact incarceration program and if the defendant successfully completes that program, the sentence imposed herein shall be reduced to time considered served upon certification to this Court by the Department of Corrections that the defendant has successfully completed the impact incarceration program.
- C. That if the defendant is not accepted for placement in the impact incarceration program, or if the defendant fails to successfully complete that program, his term of imprisonment shall be set forth in the sentencing order herein.
