**Additional Conditions of Probation/Supervised Supervision
SEX OFFENDER UNIT**

Defendant has been sentenced to a term of probation or supervised supervision and ordered to be supervised by the Sex Offender Unit of the Adult Probation Services Division of the 19th Judicial Circuit. Defendant is therefore subject to and **MUST** follow as well as comply with these additional conditions and requirements:

- A. Not reside in any house, apartment unit, condominium unit or other location where alcoholic beverages are present or regularly consumed.
- B. Report to his/her Probation Officer as often as directed and within the time frames that are directed; verify residence and employment at each office meeting; provide proof of progress in completion of treatment requirements at each office meeting; permit his/her Probation Officer to visit him/her at any location without prior notice, granting the Officer entrance and access to the extent that is necessary to carry out the duties as ordered by the Court in the probation Order; and cooperate in facilitating collateral contacts that shall be made by the Probation Officer (such as a spouse, alcohol counselor, or significant other).
- C. Comply with a daily curfew requiring Defendant to be in his/her residence except when performing probation obligations, attending treatment, working at employment approved by Probation Officer, attending court, or attending to other specific activities which have been approved in advance by his/her Probation Officer. The Defendant's Probation Officer may lessen or reinstate this curfew based upon Defendant's compliance and performance.
- D. Not change place of residence without the prior notification to and permission of his/her Probation Officer.
- E. Enter and successfully complete specialized sex offender therapy as ordered by the Court and as directed by probation.
- F. Have no contact of any kind with the victim without the approval of the Court or the express consent of probation and the therapist whichever the Court deems appropriate.
- G. Be responsible for the payment of all costs related to evaluation and treatment of himself/herself and those of the victim. The Court will determine the amount of compensation for victim therapy and the duration payment will be required.
- H. Submit to regular polygraph, plethysmograph, Abel assessment evaluations and other objective behavioral measures as ordered by the Court, as required by the treatment provider, or as directed by the Probation Officer.

- I. Refrain from the use of alcohol and illegal drugs as well as enter and successfully complete substance abuse treatment as ordered by the Court or directed by probation. Defendant will submit to random urinalysis and breathalyzer examination as directed by probation and will pay all costs associated with these tests.
- J. Not seek, find, or maintain employment that gives him/her access to minors under the age of 17 nor will he/she enter into any employment or volunteer agreement that places Defendant in authority or control over minors.
- K. Have no contact with minors under the age of 17 without order of the Court or the express consent of probation. Any permitted visitation with children will be under the supervision of a supervisor approved by probation and the therapist. The Defendant will not reside with minors under the age of 17 nor enter into any relationship giving access to minors under the age of 17 without full disclosure to the adult parent(s) or guardian(s) involved. The Defendant will refrain from frequenting or being in any location and businesses that caters to or attracts minors. The Defendant will refrain from participating in any on-line social networking site such as Myspace, Facebook et.al.
- L. Possess no sexually explicit materials including books, magazines, videos and computer transmissions. He/she will submit to all examinations by probation of phone, cable, computer and on-line services and will refrain from the purchase or use of services by which sexually explicit images are transmitted. The Defendant will turn over for inspection any cell phone, external computer storage system including external hard drives, flash drives, sandisks or any other device used for the transfer and storage of text or photos. The Defendant will not frequent any establishment that has for sale, rent, or viewing sexually explicit books, videos or live presentations of nudity or sexual activity. He/she will refrain from the rental of alternative postal services such as post boxes and fake addresses. He/she will inform probation of and provide access to each and every device in his/her residence that is capable of connecting to the internet or receiving internet material.
- M. Follow all regulations mandated by State Statute for Registration as a sex offender, HIV and STD testing, and DNA indexing.
- N. Not reside or be present within 500 feet of a park, a forest preserve, an amusement park, a licensed or unlicensed day care center, a school, a school bus stop, or other location prohibited by the Sex Offender Registration Act or other Illinois Statute.
- O. Not participate in any holiday by dressing in costume or wearing period clothing associated with the holiday nor hand out candy at Halloween. The Defendant will not dress in a Santa Claus costume or dress in an Easter Bunny costume, nor hand out gifts or Easter candy, or dress in any type of costume nor hand out gifts, candy or promotional items.
- P. Not participate in parades of any kind and not photograph, film, videotape, or at any time record any portion of a parade or any person participating in or viewing the parade. The Defendant may not have in his possession any camera or other device capable of recording sounds or images while at a parade or any other activity where children are present.
- Not use, ingest or consume any over-the-counter medication, hygiene product or other compound or product that contains alcohol, if the Court has made a finding pursuant to 730 ILCS 5/5-6-3(n).
