THE ABOVE NAMED DEFENDANT IS HEREBY ORDERED TO:

- 1) Contact SCRAM SYSTEMS OF ILLINOIS, INC. at (815) 436-3636, located at 1750 E. Main Street, Suite 80, St. Charles, Illinois 60174, within 24 hours or on the next business day for installation of the monitoring device, and complete installation within _____ (number of days).
- 2) Submit to and complete the
 - ☐ a. Secure Continuous Remote Alcohol Monitoring (SCRAM CAM) Program for order of this court _____ days or until further order of this court.

- 3) Pay a \$75.00 installation fee and a daily monitoring fee to be determined by SCRAM SYSTEMS OF ILLINOIS, INC. Defendant shall supply all necessary and requested financial information to SCRAM SYSTEMS OF ILLINOIS, INC. Failure to provide adequate financial documents will result in a monitoring fee of \$15.00 per day. Installation fee and first 30 days to be paid upon installation. Failure to keep balance current without making prior financial arrangements with SCRAM SYSTEMS OF ILLINOIS, INC. will result in revocation of participation in the SCRAM Program. If offender is 30 days behind in payments due, the Lake County State's Attorney and offender will be notified by mail that within 10 days, monitoring will cease and the SCRAM bracelet will be removed.
- 4) Completely abstain from the use of alcohol while in the SCRAM program. Defendant is not to consume or use any substance containing alcohol, or use any of the substances prohibited by the SCRAM Program rules.
- 5) NOT tamper with, obstruct or attempt to defeat the SCRAM bracelet, base station, or Remote Breath, and all equipment is to be used in accordance with the SCRAM Program rules. Tampering, obstructing or attempting to defeat the SCRAM bracelet, base station, or Remote Breath is viewed as an attempt to hide a drinking event and will result in a violation of this order.

- 6) Comply with all the terms and conditions of the SCRAM Program as stated in the SCRAM Program Participation Agreement.
